Course Description	Esthetics Advanced completes the training for esthetician. Students gain knowledge and apply theory in the following: advanced skin care and massage, hair removal, laws, rules and regulations, management, ethics, interpersonal skills and sales; advanced disinfection, safety and sanitation. Student that complete all levels of the Esthetician Program will be eligible for the Colorado Board for Barber and Cosmetology State licensure exam for Estheticians.
